-lennifer said she noticed a blog (restraining orderabuse.com) written by Todd and directed towards Tiffany. Sometime in 2012 or 2013 she then invited him out to coffee in an attempt to get him to do something was not directed at Tiffany.

- -Jennifer said she communicated with him a few times and then he became very sexual in nature and she felt he wanted some sort of financial compensation from Tiffany. Also, Todd believed that he would have been a successful writer but due to she and Tiffany he was not longer able to accomplish that goal.
- -Jennifer realized that Todd was looking for money from Tiffany and he had questions about sex for her so she ceased communication with him and contacted Tiffany to explained what happened.
- -Jennifer said Todd's blog got much worse after she contacted him as described above.
- -Jennifer said she ended up testifying against Todd in a civil case between Tiffany and Todd.
- -Jennifer believed Tiffany was granted a restraining order against Todd from the civil case which prohibited him from talking about her on the blog and prevented any libel.
- -Jennifer said the blog has adversely affected her personal and professional life,
- -Jennifer said Todd wrote about untruths on the blog including at one time about Tiffany and her stealing pharmaceuticals which was untrue.
- -Jennifer said Todd started writing threats into the blog.
- -Jennifer said Todd wrote in his blog on 10-31-15 "Your lives have an expiration date and so do you". Jennifer felt the threat was directed towards she and Tiffany and that he commonly refers to them in the blog as the "Sociopath" (Jennifer) and the "Narcissist" (Tiffany).
- -Jennifer said he also wrote, "You don't want people like me thinking about people like you, think about that". She felt that was a threat towards them as well.
- -Jennifer said she now carries a handgun due to her concern that Todd is a threat to her safety.
- -Jennifer said Todd's dog died in August of 2015 and that he had said that once he didn't have dependents he would go crazy and seek justice.
- -Jennifer believed Todd became much more aggressive in his blog after his dog died.
- -Jennifer said Todd then starting posting pictures of her and family and her colleagues and believed he violated Tiffany's court order that prohibited him from contacting her friends and family.
- -Jennifer said Todd's postings of her pictures and her email and phone number have concerned her because the information is so public now.
- -Jennifer said Todd has never contacted her directly since they met for coffee as described above. That included any Face book, phone calls, emails or in person. Also he has not contacted her through a third party.
- -Jennifer said she had made a previous police report to the University of Arizona Police Department in November of 2015 due to a concern about the "expiration date" threat. Jennifer said her employed to the report but no charges have been applied to Todd.
- -Jennifer said she did not currently have a restraining order against Todd.
- -Jennifer said Todd posted images on his blog after his dog died that she believed was related to possible suicidal feelings. The images showed pills and depression.
- -Jennifer said she believed Todd posted several blogs in which she believed he was a danger to others which included seeking retribution and "going biblical" and "seeking his own justice".
- -Jennifer said she believed Todd stated he had depression from a previous court hearing.
- -Jennifer denied trying to contact Todd after the coffee meeting as described above.
- -Jennifer said due to Todd "stagging" her work photograph and name so many times in the blogs that when her colleagues google her name after she publicly speaks the first thing that always comes up is the blog and defaming information about her.
- -Jennifer felt she was being harassed due to the above information.

Interview ended.

Jennifer went over several of the printouts of Todd's blog that she sent me via email. Jennifer showed me a blog printout that appeared to have been posted on 10-09-15 that showed her work photograph had been tagged to go to his blog instead of her work. Also, on the same posting, her
